TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment"), effective as of May 24, 2013 (the Effective Date"), is made by and between, Navee Technologies, LLC, a Texas Limited Liability Company ("Assignor") and Airo Wireless, LLC, a Georgia Limited Liability Company ("Assignee").

WHEREAS, Assignor is the owner of, and desires to assign to Assignee, all right, title and interest in and to: (i) any and all trademark, and intellectual property rights, including rights of priority, and registration for the mark/name ISAFE identified under US Registration No. 3,611,792 ("the Mark"); and (ii) any and all goodwill of the business associated with the Mark; and

WHEREAS, Assignee desires to acquire the Mark and any and all goodwill of the business associated therewith from Assignor, subject to the terms and conditions of this Assignment; and

WHEREAS, Assignor and Assignee desire to confirm of record the assignment of the Mark and goodwill to Assignee;

NOW, THEREFORE, in consideration of the foregoing recitals, the mutual covenants and conditions contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignor hereby assigns to Assignee all right, title and interest in and to the Mark and the associated U.S. Trademark Registration No. 3,611,792 (the "Registration"), together with: (i) the goodwill of the business symbolized by the Mark; (ii) all causes of action, claims and demands and other rights for, or arising from, any infringement or misappropriation, including past infringements and misappropriations, of the Mark; and (iii) any royalties or other consideration owed in connection with use of the Mark after the Effective Date.
2. Assignor further agrees without further consideration to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Mark, the Registration, the goodwill and all other rights hereby conveyed.
3. Subject to the terms hereof, Assignee accepts such assignment of the Mark, the Registration, and the goodwill.


