GRANT OF SECURITY INTEREST (TRADEMARKS)

The undersigned, ODYSSEY LOGISTICS & TECHNOLOGY CORPORATION, a Delaware corporation (the "**Borrower**"), ODYSSEY TRANSPORT LLC, a Delaware limited liability company ("**Odyssey Transport**"), ODYSSEY INTERNATIONAL LLC, a Delaware limited liability company ("**Odyssey International**"), ODYSSEY OVERLAND LLC, a Delaware limited liability company ("**Odyssey Overland**"), INTERNATIONAL FORWARDERS, INC., a South Carolina corporation ("**Forwarders**"), CAPITAL TRANSPORTATION SOLUTIONS LLC, a Delaware limited liability company ("**Capital**"), CHEMICAL MARKETING CONCEPTS LLC, a Delaware limited liability company ("**Chemical LLC**"), CHEMICAL MARKETING CONCEPTS INTERNATIONAL, INC., a Connecticut corporation ("**Chemical Inc.**"), OPTIMODAL, INC., a Pennsylvania corporation ("**Optimodal**"), UNIGLOBAL LOGISTICS LLC, a Delaware limited liability company ("**Uniglobal**"), INTERDOM LLC, a Delaware limited liability company ("**Interdom**"), and OL&T FOODTRANS LLC (f/k/a OL&T Energy Services LLC f/k/a Commercial Cartage LLC), a Delaware limited liability company ("**Foodtrans**"; and collectively with Odyssey Transport, Odyssey International, Odyssey Overland, Forwarders, Capital, Chemical LLC, Chemical Inc., Optimodal, Uniglobal, and Interdom, the "**Guarantors**" and together with the Borrower, collectively, the "**Grantors**"), are obligated to the lenders (the "**Lenders**") from time to time party to the Credit Agreement (defined in the Security Agreement referred to below) and JPMorgan Chase Bank, N.A., as administrative agent for the Lenders (the "**Administrative Agent**"), and have entered into the Continuing Pledge, Security Agreement and Assignment, dated as of May 24, 2013 (as amended, supplemented or otherwise modified from time to time, the "**Security Agreement**"), in favor of the Administrative Agent.

Pursuant to the Security Agreement, each of the Grantors granted to the Administrative Agent a security interest in and to all of the right, title and interest of such Grantor in and to the trademarks listed on Schedule 1, which trademarks are registered in the United States Patent and Trademark Office (the "**Trademarks**"), together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (the "**Collateral**"), to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement).

For good and valuable consideration, the receipt of which is hereby acknowledged, and for the purpose of recording the grants of the security interest as aforesaid, each of the Grantors does hereby further assign to the Administrative Agent, and grants to the Administrative Agent a security interest in, the Collateral to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement).


