TRADEMARK ASSIGNMENT

Assignor hereby covenants and agrees that Assignor will at any time, upon the request and at the expense of Assignee, execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect title in the Marks in the name of Assignee.
