**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of May 17, 2013 by JPMORGAN CHASE BANK, N.A., (the "Administrative Agent") to MEDEGEN MEDICAL PRODUCTS, LLC, (the "Grantor"), as follows:

WHEREAS, on August 27, 2010, the Grantor, certain of its affiliates and the Administrative Agent entered into a Pledge and Security Agreement (the "Security Agreement") and the Grantor and the Administrative Agent entered into a Confirmatory Grant of Security Interest in United States Trademarks (the "Confirmatory Grant");

WHEREAS, said Confirmatory Grant was recorded in the United States Patent & Trademark Office on August 27, 2010 at reel/frame 004268/0981; and


WHEREAS, the Administrative Agent wishes to release its security interest in the Marks.
