## CONFIRMATORY ASSIGNMENT AND CONSENT

**THIS CONFIRMATORY ASSIGNMENT AND CONSENT** (the "Agreement") is made as of the 20th day of June, 2013, by **SEEVAST CORP., PULSE 360, INC., KANOODLE.COM, INC., SYNDIGO, INC.** (collectively the "Assignor") and the **MANUFACTURERS AND TRADERS TRUST COMPANY** (the "Secured Creditor"), in favor and for the benefit of **680 MEDIA, INC.** ("Assignee").

**WHEREAS**, the Secured Creditor and Assignee entered into a Memorandum of Secured Creditor's Sale as of April 15, 2013 ("Secured Creditor's Sale") wherein pursuant to §9-610 et seq. of the New York Uniform Commercial Code all of the Assignors' rights, title and interest in and to the following were transferred and assigned to Assignee: [1] those certain registrations, trademark applications, trademarks as specifically set forth and described on **Exhibit A** attached hereto and made a part hereof (collectively the "Marks"); and [2] those certain patents, patent applications and inventions as specifically set forth and described on **Exhibit B** attached hereto and made a part hereof (collectively the "Patents"); and

**WHEREAS**, to facilitate and compliment the Assignee's acquisition of the Marks and Patents (collectively, the "Transferred Intellectual Property"), the Assignor confirms it did transfer to Assignee the underlying goodwill associated with the Transferred Intellectual Property under the Secured Creditor's Sale.

**NOW, THEREFORE**, for good and valuable consideration paid by Assignee to Assignor, the receipt and sufficiency of which are hereby acknowledged it is hereby agreed as follows:

- (1) All of the above recitals are incorporated herein and made a part hereof in their entirety.
- (2) Assignor does hereby ratify and confirm that Assignee did acquire and purchase the Transferred Intellectual Property pursuant to the aforesaid Secured Creditor's Sale and in furtherance of the same, the Assignor hereby irrevocably sells, transfers, assigns, sets over and conveys to the Assignee, all of Assignor's right, title, and interest in and to the Marks, including the goodwill of the business symbolized by the Marks, and the Patents, and Assignor's entire right, title, and interest in and to any claims in law or equity, including without limitation the right to sue for and collect damages arising out of any past, present or future infringement or other unauthorized use of the Transferred Intellectual Property. Notwithstanding, the Assignor has no actual knowledge of any such infringements.
- (3) By executing this Agreement, the Secured Creditor waives, relinquishes and terminates any interests, including any liens and security interests, in or associated with the Transferred Intellectual Property.
- (4) Assignor agrees that, upon reasonable request by Assignee and at Assignee's expense, Assignor shall execute all papers, instruments, documents, and agreements, make all rightful oaths, testify on behalf of Assignee, and do all other lawful acts necessary or appropriate to carry out the intent of this Confirmatory Assignment, as well as provide such other material, information, or assistance as may be necessary or desirable to carry out the intent of this Confirmatory Assignment.
- (5) This Agreement shall be binding upon Assignor and the Secured Creditor and shall inure to the benefit of Assignee and its representatives, successors, and assigns.

This Agreement may be signed in one or more counterparts with the same legal effect as if all signatures appeared on the same execution page.
