TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of July 1 2013 ("**Release**"), is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH as Second Lien Collateral Agent ("**Collateral Agent**"), in favor of AMF BOWLING WORLDWIDE, INC., a Delaware corporation ("**Grantor**").

WHEREAS, pursuant to (a) that certain Second Lien Security Agreement dated as of June 12, 2007 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "**Security Agreement**") by and among the Grantor, Collateral Agent, and others party thereto and (b) that certain (i) Assignment of Security Interest in United States Patents and Trademarks, dated as of February 27, 2004 and recorded at the United States Patent and Trademark Office ("**USPTO**") on February 27, 2004 at Reel 2813 Frame 0175 and (ii) Assignment of Security Interest in United States Patents and Trademarks, dated as of June 12, 2007 by and among the Grantor and Collateral Agent, dated as of June 12, 2007 and recorded at the USPTO on June 25, 2007 at Reel 3567 Frame 0828 (collectively, the "**Trademark Security Agreements**"), Grantor granted to the Collateral Agent a continuing security interest in all of Grantor's right, title and interest in, to and under the Trademark and Patent Collateral.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Collateral Agent and Grantor agree as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreements (as applicable).

**SECTION 2. Termination and Release.** Collateral Agent hereby:

- (a) terminates the Trademark Security Agreements;
- (b) terminates, cancels, forever discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under the Trademark and Patent Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto; and
- (c) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**SECTION 4. Further Assurances.** Collateral Agent, at Grantor's expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein.
