RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of June ²⁸ 2013, is made in favor of **Profile Products, LLC** having an address at 750 Lake Cook Rd, Suite 440, Buffalo Grove, IL 60089 (the "Grantor") by **Bank of Montreal**, a Chartered Bank of Canada, having a place of business at 111 West Monroe St., Chicago, IL 60603 as Administrative Agent (the "Administrative Agent"), pursuant to the Trademark Collateral Agreement, dated as of **May 17, 2007** (the "Security Agreement") among Profile Products, LLC, as borrower (the "Borrower"), the guarantors party thereto (the "Guarantors"), the lenders party thereto and the Administrative Agent.

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement among the Borrower and the Guarantors, the Grantor granted to the Administrative Agent a continuing security interest in all of its right, title and interest in and to the Trademarks including, without limitation, the Trademark registrations and applications set forth on **Schedule I** hereto together with the goodwill associated therewith (collectively, the "Trademark Collateral"); and

WHEREAS the Trademark Security Agreement relating to the Trademark Collateral has been recorded with the Assignments Division of the U.S. Patent and Trademark Office on **May 29, 2007** at **Reel 3551 and Frame 0253**.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademark Collateral (including without limitation, for the avoidance of doubt, any Trademark Collateral, whether registered or unregistered).

If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Trademark Collateral, it hereby assigns and transfers such rights, title or interest to the Grantor.

The Administrative Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to further evidence and effectively effectuate the purposes of this Release.

This Release shall be construed in accordance with and governed by the laws of the State of Illinois.
