RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (“**Agreement**”), dated as of July 12, 2013, is made by Fifth Third Bank, an Ohio banking corporation, as Secured Party (as defined in the Trademark Security Agreement, as defined below, “**Secured Party**”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Security Agreement (as defined therein), as applicable.

WHEREAS, Champion Publishing, Inc., a West Virginia corporation (“**Debtor**”) and Secured Party are parties to that certain Trademark Security Agreement dated as of September 14, 2007 (the “**Trademark Security Agreement**”), which was recorded with the United States Patent and Trademark Office on September 14, 2007 in its records at Reel 3621, Frame 0409;

WHEREAS, pursuant to the Trademark Security Agreement, Debtor unconditionally granted, assigned and pledged to Secured Party (all of the following being, collectively, the “**Trademark Collateral**”): (a) each trademark, trademark registration and trademark application listed on Schedule I attached hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and (b) all proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration or trademark application listed on Schedule I or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark application, in each case together with the right to sue for and collect said damages; and


WHEREAS, Secured Party desires to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates its security interest in, liens on, and all other rights in, to and under the Trademark Collateral and any and all other rights it may have under the Trademark Security Agreement.
