**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of July 15, 2013 (the “Effective Date”) by **OBSIDIAN AGENCY SERVICES, INC.**, as administrative agent (in such capacity, the “Agent”) for the Lenders and other Secured Parties (each as defined below), in favor of **HANLEY-WOOD, LLC** (the “Grantor”).

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of May 23, 2013 (the “Trademark Security Agreement”), made by the Grantor in favor of the Agent, the Grantor granted to the Agent for the benefit of the Lenders and the other Secured Parties (each as defined in the Credit Agreement referred to in the Trademark Security Agreement), a continuing security interest in and to all of the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the trademark set forth on Schedule 1 attached hereto;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 30, 2013, at Reel/Frame 5038/0242; and

**WHEREAS**, the Grantor has requested that Agent provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest and continuing lien on the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, without any representation or warranty, and without recourse to Agent or any Secured Party, hereby (a) terminates the Trademark Security Agreement, and (b) terminates, cancels and releases any and all security interests it has against the Trademark Collateral.

For the avoidance of doubt, nothing in this Release of Security Interest in Trademarks shall be deemed a representation or warranty with respect to the Trademark Collateral, the Grantor's or the Agent's right, title or interest therein or thereto, or the release granted herein, and neither the Grantor nor any other third party shall have any recourse against the Agent or any Secured Party, in any way in connection with the Trademark Collateral or this Release of Security Interest in Trademarks.
