**TRADEMARK ASSIGNMENT**

Assignor hereby assigns to Assignee all right, title and interest in and to the Marks, together with the goodwill associated with the Marks, and any and all registrations and applications for registration of the Marks, and also including, without limitation, any and all rights to petition, sue or otherwise seek and recover damages, profits and any other remedy (monetary, injunctive, declaratory or other), for any past, present or future infringement, dilution, conversion or misappropriation of, or other injury, offense, violation, breach of duty or wrong relating to the Marks.
2. Assignor warrants that it has good title to the Marks, free and clear of any liens, pledges, security interests and encumbrances, that it has no actual or constructive knowledge of any claims that the Marks infringe, dilute, or otherwise misappropriate the intellectual property rights of another, and that it has full and complete power and authority to sell, transfer and assign the Marks to Assignee.
3. In consideration for the assignment described in this Agreement, Assignee agrees to pay Assignor \$10.00, to reimburse Assignor for the costs incurred for the registration.


