RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of May 3, 2013 ("Effective Date") between TRIANGLE CAPITAL CORPORATION, in its capacity as collateral agent (the "Collateral Agent"), and WYTHE WILL TZETZO, LLC, a Maryland limited liability company (the "Grantor").
