**CONFIRMATORY ASSIGNMENT OF THE TRADEMARK
ASPEN IPROPERTY**

THIS CONFIRMATORY ASSIGNMENT (hereinafter "Assignment") is made effective as of **FEBRUARY 26, 2010** from Aspen Grove, Inc., a corporation of the State of Delaware, with its address being 5940 Frederick Crossing Lane, Suite 201, Frederick, MD 21704 (hereinafter "Assignor"), to Aspen Connect Limited, a corporation of Ireland, with its address being Kerry Technology Park, Dromtacker, Tralee, County Kerry, Ireland (hereinafter "Assignee").

WHEREAS, Assignor and Assignee have and have at all times material hereto had a mutual intent, understanding, and expectation that certain intellectual property rights, specifically including the entire right, title and interest in and to the trademark **ASPEN IPROPERTY** together with the good will of the business symbolized by **ASPEN IPROPERTY** in the United States, and the application for registration of **ASPEN IPROPERTY**, S.N. 77/945,567, filed on February 26, 2010 with the United States Patent and Trademark Office that issued as Registration No. 3,899,110 on January 4, 2011 ("Trademark") was at all times and should have been owned by and the property of Assignee;

WHEREAS, the ownership of the Trademark by the Assignee is not accurately reflected by records relating to the registration application and registration of the Trademark in the United States Patent and Trademark Office due to an administrative error.

NOW, THEREFORE for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor, without reservation:

(1) Confirms that it has assigned, transferred, and conveyed to Assignee, its successors and assigns, the whole entire right, title, and interest in and to the trademark **ASPEN IPROPERTY**, together with the good will of the business symbolized by the trademark **ASPEN IPROPERTY**, the registration application S.N. 77/945,567 (from the time of filing) that issued as Registration No. 3,899,110 on January 4, 2011, and all rights to sue for and collect damages resulting from past, present, and future infringement of the trademark **ASPEN IPROPERTY** in the United States.

(2) Authorizes and respectfully requests the Commissioner of Patents and Trademarks of the United States to issue or transfer the registration of the trademark ASPEN IPROPERTY to Assignee, as Assignee of the entire right, title, and interest therein, or otherwise as Assignee may direct.
