RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated August 1st, 2013 by FIFTH THIRD BANK, an Ohio banking corporation ("*Fifth Third*") with its mailing address at 222 S. Riverside Plaza, Chicago, IL 60606, acting as administrative agent hereunder for the Secured Creditors defined in that certain Agreement hereinafter defined (Fifth Third acting as such administrative agent being hereinafter referred to as "*Secured Party*");

WITNESSETH:

WHEREAS, Infinium IP, LLC, a Delaware limited liability company ("*Debtor*"), with its mailing address at 600 W. Chicago Avenue, Suite 300N, Chicago, Illinois 60654, and Secured Party were parties to a certain Trademark Collateral Agreement dated April 30, 2012 between Debtor and Secured Party which was recorded in the United States Patent and Trademark Office on May 3, 2012 at Reel 4772, Frame 0021 (the "*Agreement*"), pursuant to which Debtor granted to Secured Party, a security interest in and collateral assignment of, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and

WHEREAS, Debtor has requested that Secured Party release its security interests in the Trademark Property and reassign the same to Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Secured Party hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Secured Party, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto, and:

(i) Each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and

(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
