TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of August 13, 2013, by PNC Bank, National Association, as lender and as agent ("Grantee").

WITNESSETH:

WHEREAS, Grantee and Johnson Industries, Inc., a Georgia corporation ("Grantor"), entered into that certain Grant of Security Interest in United States Trademark dated as of March 1, 2011 (the "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which Grantor granted a security interest to Grantee in, among other things, all of Grantor's right, title and interest in and to the United States trademark number 2587593 registered on July 2, 2002 (the "Mark"); and

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark office on March 3, 2011, at Reel 4608, Frame 0110; and

WHEREAS, Grantee no longer has an interest in the Mark; and

WHEREAS, Grantor has requested that Grantee release its lien on the Mark and reassign the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby releases any and all claims, liens, and other encumbrances arising under the Security Agreement and reassigns any and all rights, titles and interests conveyed thereunder, without any representation, recourse or undertaking by Grantee, to Grantor.
