Under Section 904 of the Business Corporation Law. We, the undersigned being respectively the President and Secretary of Dynalab Corp<sup>ATION</sup> and the President and Secretary of Megadyne Corp., certify:

1. The name of each constituent corporation is as follows: Dynalab Corp<sup>ATION</sup> (hereinafter "Dynalab") and Megadyne Corp. (hereinafter "Megadyne"). The name of the surviving corporation is Megadyne Corp.

2. The number of outstanding shares of Dynalab is 127,221 shares at a par value of \$.20 each, all of which are entitled to vote. The number of outstanding shares of Megadyne is 131,972 shares at a par value of \$.02 each, all of which shares are entitled to vote. The number of outstanding shares of both corporations shall not change prior to the effective date of this merger.

3. Paragraph 1 of the Certificate of Incorporation of Megadyne is amended to read as follows to reflect a change in the name of the corporation:

"The name of the corporation shall be Dynalab Corp."

4. The effective date of the merger shall be the date of filing of this Certificate of Merger by the Department of State of the State of New York.

5. The Certificate of Incorporation of Dynalab was filed by the Department of State on February 17, 1959, <sup>under the name Dynalab Corp</sup> and the Certificate of Incorporation of Megadyne was filed by the Department of State on July 10, 1987.

6. The Plan of Merger was authorized at a Meeting of the Shareholders of Dynalab, by the holders of two-thirds (2/3) of all outstanding shares entitled to vote thereon; and at a meeting of the Shareholders of Megadyne Corp., by a vote of the holders of two-thirds (2/3) of all outstanding shares entitled to vote thereon. The laws of the State of New York permit a merger as herein effected.

7. The Plan of Merger has not been abandoned.


