TRADEMARK LICENSES

Pursuant to Section 4.1 of the Transition Services Agreement, dated as of the date hereof, by and among CEG Holdings, Inc., YRC Logistics Services, Inc. ("YRC Logistics Services"), YRC Enterprise Services, Inc. ("YRC Enterprise Services") and YRC Worldwide Inc. ("YRCW" and together with YRC Logistics Services and YRC Enterprise Services, "YRC Companies"), YRCW grants to CEG Holdings, Inc. and its subsidiaries an exclusive, non-transferable, royalty-free license, ending 180 days after the date hereof, to use all trademarks and logos that are owned or controlled by the YRC Companies or any of their affiliates that were customarily used in certain business lines related to the business of YRC Logistics, Inc. in a given location within the one year period prior to the execution of the Acquisition Documents, including the following registered trademark owned by YRCW:
