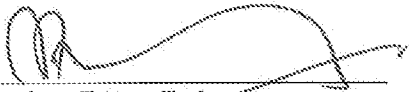
Substituting the following section I in lieu of the existing section I:

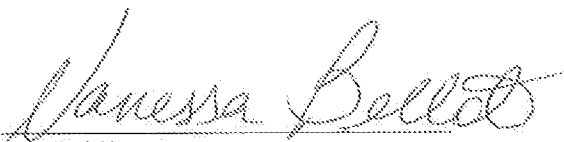
