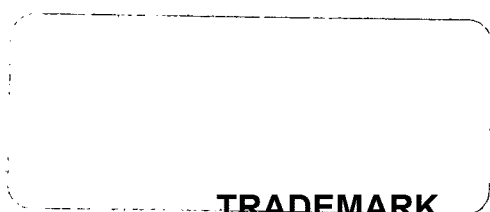

WHEREAS the Assignor is the proprietor of the Trade Mark registrations listed in the attached Schedule "A", hereinafter called "the Trade Marks";


AND WHEREAS the Assignee is desirous of acquiring all rights in or to the Trade Marks;






