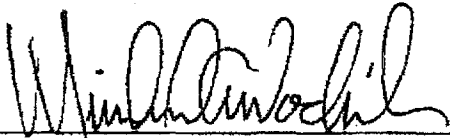

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of this Corporation is Coastal Industries, Inc. of Jacksonville.
2. Paragraph 1 of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:
 - "1. The name of the corporation shall be Coastal Industries, Inc."
3. The foregoing amendment was approved by the Board of Directors of the Corporation by Unanimous Written Consent on October 6, 2003, and it was recommended that the Articles of Amendment be presented to the Shareholders for adoption at a special meeting.
4. The foregoing amendment was adopted pursuant to Section 607.1003, Florida Statutes, by Written Consent of the Shareholders on October 6, 2003; the unanimous vote of the Shareholders for the amendment was sufficient for approval.
