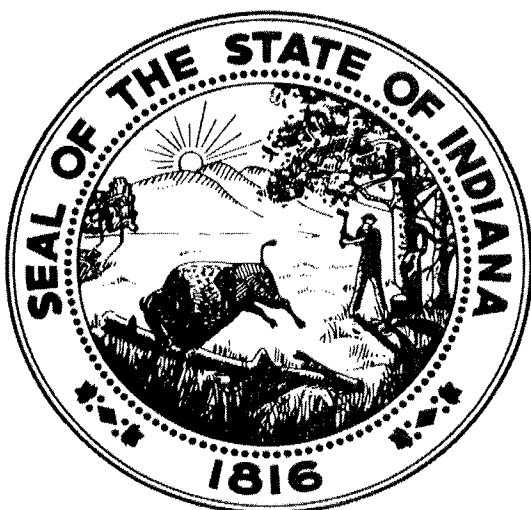

ARTICLES OF ENTITY CONVERSION
OF
USIC LOCATING SERVICES, INC.,
AN INDIANA CORPORATION,
INTO
USIC LOCATING SERVICES, LLC,
AN INDIANA LIMITED LIABILITY COMPANY

The undersigned, acting as a duly authorized officer of USIC LOCATING SERVICES, INC., an Indiana corporation (the “**Corporation**”), in compliance with the Indiana Business Corporation Law, as amended (the “**IBCL**”), and desiring to effect a conversion of the Corporation into an Indiana limited liability company (the “**Conversion**”), hereby sets forth the following Articles of Entity Conversion (these “**Articles**”) effective as of August 30, 2013 (the “**Effective Time**”):

Article 1. CONVERTING CORPORATION

Section 1.1 **Name.** The name of the corporation being converted is “USIC Locating Services, Inc.”

Section 1.2 **Jurisdiction.** The Corporation is an Indiana for-profit corporation existing pursuant to the provisions of the IBCL.

Article 2. SURVIVING COMPANY

Section 2.1 **Name.** The name of the limited liability company following the Conversion is “USIC Locating Services, LLC” (the “**Surviving Company**”).

Section 2.2 **Jurisdiction.** The Surviving Company is an Indiana limited liability company existing pursuant to the provisions of the Indiana Business Flexibility Act, as amended (the “**Act**”).

Article 3. PLAN OF CONVERSION

The Plan of Entity Conversion to effectuate the Conversion, containing such information as required by Ind. Code § 23-1-38.5-11, was properly adopted and approved as described below (the “**Plan of Conversion**”).

Article 4. EFFECTIVE TIME

The effective time of these Articles of Entity Conversion (the “**Articles of Conversion**”) shall be 12:01 a.m. on August 30, 2013 (the “**Effective Time**”).

ARTICLES OF ORGANIZATION
OF
USIC LOCATING SERVICES, LLC

Effective as of the 30th day of August, 2013, the undersigned, desiring to form a limited liability company (the “**Company**”) pursuant to the provisions of the Indiana Business Flexibility Act, as amended (the “**Act**”), hereby executes these Articles of Organization:

Section 1. **Name.** The name of the limited liability company is “USIC Locating Services, LLC”.

Section 2. **Registered Office and Registered Agent.** The street address of the Company’s registered office in Indiana is 9045 North River Road, Suite 300, Indianapolis, Indiana 46240, and the name of the Company’s registered agent at that office is Phillip Kryder.

Section 3. **Term of Existence.** The duration of the Company is perpetual until dissolved in accordance with the Act and the operating agreement of the Company, if any.

Section 4. **Operating Agreement.** Any operating agreement of the Company must be in writing.

Section 5. **Management.** The Company shall be managed by its members in accordance with the Act.
