## RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Home Physicians Management LLC, a Delaware limited liability company with offices located at 1340 South Damen Avenue, Suite 210, Chicago, Illinois (the "Grantor") granted a security interest in and lien upon certain trademarks and related rights to Triangle Capital Corporation, a Maryland corporation with offices located at 3700 Glenwood Avenue, Suite 530, Raleigh, North Carolina ("TCAP"), acting as administrative agent (the "Administrative Agent") for the ratable benefit of the banks and other financial institution from time to time parties to that certain Note Purchase Agreement dated as of March 25, 2011, as amended by that certain First Amendment to Note Purchase Agreement dated January 3, 2012, Second Amendment to Note Purchase Agreement dated February 7, 2012 and Third Amendment to Note Purchase Agreement dated January 28, 2013 (as further amended, supplemented or otherwise modified through the date hereof, the "Note Purchase Agreement") by and among Grantor, TCAP and Triangle Mezzanine Fund II, LP, a Delaware limited partnership ("TMF II" and together with TCAP, the "Lenders"), and certain other documents, instruments and agreements including that (b) that certain Trademark Security Agreement made by Grantor in favor of TCAP dated March 25, 2011 (collectively with any other agreements, instruments, or other documents in connection with any of the foregoing, the "Triangle Documents"); and

WHEREAS, the Triangle Documents granted to Administrative Agent a security interest in certain trademarks and related rights of Grantor, all as described in more detail in the Triangle Documents, including the trademarks, trademark applications and trademark registrations identified in Schedule A affixed hereto and incorporated herein by reference (collectively, the "Trademark Collateral");

WHEREAS, an executed copy of the Security Agreement was recorded in the U.S. Patent and Trademark Office (the "USPTO") on March 25, 2011, at Reel 004507, Frame 0635;

WHEREAS, Grantor has fulfilled its obligations under the Triangle Documents and has requested that the Administrative Agent terminate the Security Agreement and other Triangle Documents and release its security interest in and lien on the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent hereby:

1. terminates and releases in its entirety, for the benefit of Grantor and its successors and assigns, the security interest granted to Administrative Agent in the Trademark Collateral;
2. agrees that the Security Agreement is hereby canceled and terminated, including all rights and obligations of the parties thereunder; and
3. authorizes Grantor, or an authorized representative of Grantor, to record this release with the USPTO.

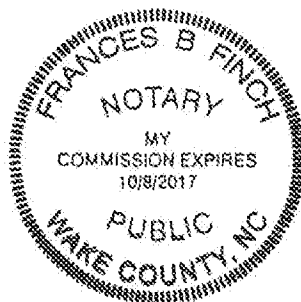
