the trademarks including the right to bring proceedings for passing off and together with any goodwill in the trademarks built up by their use in the United States.


2. The Assignor confirms authorization for the United States representatives to execute the forms of application required to record on the United States Trademarks Register the change of ownership effected in this agreement.
3. This Assignment is binding upon the parties, their successors and assigns.


