GGH hereby agrees, without consideration, to communicate to GL, any facts known to it respecting the inventions disclosed and claimed in the Assigned Intellectual Property, and to testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title in GL to any Assigned Intellectual Property and the inventions disclosed and claimed therein, to execute all divisional, continuation, continuation-in-part, reexamination, and reissue applications, make all rightful oaths, and generally do everything possible to aid GL to obtain and enforce proper patent protection throughout the world for the inventions disclosed and claimed in the Assigned Intellectual Property, it being understood that any expense incident to the execution of such papers shall be borne by GL.
