NUNC PRO TUNC ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

In consideration of One Dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, HOLLYMATIC CORPORATION, an Illinois corporation (now HCOLD, Inc., an Illinois corporation) (hereinafter "said assignor"), does hereby assign and confirm assignment to HOLLYMATIC CORPORATION, LTD., a Nevada limited liability company (formerly Hollymatic Sales LLC, a Nevada limited liability company) (hereinafter "said assignee"), *nunc pro tunc* effective June 29, 2012, all of said assignor's right, title and interest in and to all Intellectual Property of said assignor, including the patents, trademark registrations and applications therefor, including those shown in Attachment A and Attachment B hereto, together with the goodwill of the said assignor's business symbolized thereby and the right to sue and collect damages for any past infringement thereof.

As specifically defined in the July 29, 2012 Asset Purchase Agreement between the predecessor companies of said assignor and said assignee and Exhibit 4.2(a) thereto ("General Instrument of Transfer, Assignment and Bill of Sale"), Intellectual Property means: (a) all inventions (whether patentable or unpatentable and whether or not reduced to practice), all improvements thereto, and all patents, patent applications, and patent disclosures, together with all reissuances, continuations, continuations-in-part, revisions, extensions, and reexaminations thereof (including but not limited to the Intellectual Property identified on Attachment A); (b) all trademarks, service marks, trade dress, logos, trade name, and corporate names, together with all translations, adaptations, derivations, and combinations thereof and including all goodwill associated therewith, an all applications, registrations, and renewals in connection therewith

(including but not limited to the Intellectual Property identified on Attachment B); (c) all copyrightable works, all copyrights, and all applications, registrations, and renewals in connection therewith; (d) all mask works and all applications, registrations, and renewals in connection therewith; (e) all trade secrets and confidential business information (including ideas, research and development, know-how, formulas, compositions, manufacturing and product processes and techniques, technical data, designs, drawings, specifications, mailing lists, customer and supplier lists, pricing and cost information, and business and marketing and proposals); (f) all computer software (including data related documentation); (g) another proprietary rights; and (h) all copies and tangible embodiments thereof (in whatever form or medium).
