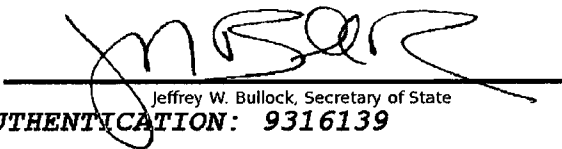

Pursuant to Section 18-209 of the Limited Liability Company Act of the State of Delaware
and Section 264 of the General Corporation Law of the State of Delaware

FIRST: The name and jurisdiction of formation or organization and domicile of each of the constituent entities is: Deluxe Media Services LLC, a Delaware limited liability company (the "LLC") and Deluxe Illinois Inc., a Delaware corporation (the "Corporation").

SECOND: The LLC and the Corporation have entered into an Agreement of Merger, dated as of January 20, 2012 (the "Merger Agreement"), providing for the merger of the Corporation with and into the LLC pursuant to Section 18-209 of the Limited Liability Company Act of the State of Delaware (the "DLLCA") and Section 264 of the General Corporation Law of the State of Delaware (the "DGCL"). The Merger Agreement has been approved, adopted, certified, executed and acknowledged in accordance with Sections 18-204 and 18-209 of the DLLCA, in the case of the LLC, and Sections 103 and 264 of the DGCL, in the case of the Corporation.

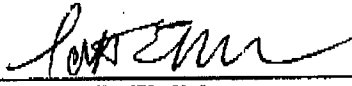
THIRD: Deluxe Media Services LLC shall be the surviving entity of the merger (the "Surviving LLC").

FOURTH: The Merger Agreement is on file at an office of the Surviving LLC at 1377 North Serrano Avenue, Hollywood, CA 90027. A copy of the Merger Agreement will be furnished by the Surviving LLC, on request and without cost, to any member of the LLC or to any stockholder of the Corporation.

FIFTH: This Certificate of Merger shall be effective at on January 23, 2012.
