TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement"), dated as of August 20, 2012, is entered into by and between Revlon Consumer Products Corporation, a Delaware corporation ("Assignor"), and Minerals Cosmetics LLC, a limited liability company organized under the laws of the State of New Jersey ("Assignee").

WHEREAS, Assignee wishes to acquire the Trademarks from Assignor and Assignor desires to sell, assign and transfer the Trademarks to Assignee.

NOW, THEREFORE, in consideration of the premises and the mutual covenants set forth herein and in the Purchase Agreement, the parties hereto hereby agree as follows:

For good and valuable consideration, as set forth in the Purchase Agreement, and in consideration of the transactions contemplated by the Purchase Agreement, Assignor hereby assigns and transfers unto Assignee, forthwith, all of Assignor's right, title and interest in and to the Trademarks throughout the world, to have and hold the same for itself, its successors and assigns forever.

By this Agreement, Assignee accepts the assignment and transfer of the Trademarks.
