ARTICLES OF ORGANIZATION
 INCLUDING ARTICLES OF CONVERSION

Pursuant to §§ 57C-2-21, 57C-9A-01 and 57C-9A-03 of the General Statutes of North Carolina, the undersigned converting business entity does hereby submit these Articles of Organization Including Articles of Conversion for the purpose of forming a limited liability company.

1. The name of the limited liability company is: PEAK PERFORMANCE SPORTS AND PHYSICAL THERAPY, LLC.

The limited liability company is being formed pursuant to a conversion of another business entity.

2. The name of the converting business entity is DTP PEAK PERFORMANCE SPORTS AND PHYSICAL THERAPY, INC. and the organization and internal affairs of the converting business entity are governed by the laws of the state or country of North Carolina.
