Assignor hereby assigns, grants, transfers, and otherwise conveys to Assignee, all of Assignor's rights, title and interest in, to, and under the Trademarks (all such rights, title, and interest being collectively referred to in the balance of this Agreement as the "Rights"), including without limitation any and all common law rights in, to, and under the Trademarks, applications to register the Trademarks, registrations for the Trademarks, and the goodwill symbolized by the Trademarks, all as of the Effective Date and subject to the terms of this Agreement.
 - 2. Assignee hereby accepts from Assignor all of Assignor's Rights as of the Effective Date.
- 3. As of the Effective Date, Assignor hereby transfers, conveys and assigns to Assignee, and Assignee hereby accepts from Assignor, Assignor's rights, title and interest in and to any and all causes of action related to the Trademarks and rights of recovery for past infringement of the Trademarks.
- 4. This Agreement shall be binding upon and inure to the benefit of Assignor and Assignee, and their respective successors and assigns. This instrument shall not confer any rights or remedies upon any third party.
- 5. This Agreement sets forth the entire understanding and agreement, whether written or oral, between Assignor and Assignee with respect to the matters set forth in this Agreement. No amendment of any terms of this Agreement, waiver of the obligations of Assignor or Assignee


