**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, effective as of November 21, 2013, is granted by Crystal Financial LLC, with its principal office at Two International Place, Boston, Massachusetts, 02110 to Freedom Communications, Inc., a Delaware corporation (the "Grantor"), with its principal office at 625 N. Grand Avenue, Santa Ana, CA 92701, as follows:

WITNESSETH

WHEREAS, the Grantors have heretofore granted Crystal Financial LLC ("Crystal") as agent for the Lender Group ("Agent") a security interest in certain intellectual property rights, including without limitation the trademarks, trademark registrations, trademark applications and the goodwill associated therewith, patents and patent applications and other intellectual property, including the intellectual property set forth on Schedule A attached hereto (collectively, the "Intellectual Property"), pursuant to (i) that certain Guaranty and Security Agreement dated as of July 25, 2012, by and among the Grantor, the other grantors party thereto and the Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") and (ii) that certain First Lien Trademark Security Agreement dated as of July 25, 2012 by and among the Grantor, the other grantors listed therein and the Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"); and

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Intellectual Property to the Grantor and to dissolve any and all liens and encumbrances respecting the Intellectual Property including the Intellectual Property shown on the attached Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby, without recourse and without representation or warranty of any kind (either express or implied), releases, discharges, quit claims and relinquishes unto the Grantor any and all right, title and interest in and to the Intellectual Property granted to the Agent by the Grantor by the Security Agreement and the Trademark Security Agreement, which was duly recorded on July 26, 2012, at Trademark Reel 4829, Frame 0818 in the United States Patent and Trademark Office, and further the Agent hereby releases all other rights it may have under the Security Agreement and the Trademark Security Agreement with respect to the Intellectual Property, and cancels such agreements with respect to the Intellectual Property, effective as of the date above written.
