## TRADEMARK AND SERVICE MARK ASSIGNMENT

Capitalized terms not expressly defined in this Assignment shall have the meanings ascribed to them in the asset purchase agreement, dated as of the date hereof, by and among the Assignor, the Assignee and a certain other party (the "*Asset Purchase Agreement*").

WHEREAS, pursuant to the Asset Purchase Agreement, the Assignee has agreed to acquire all of the Assignor's right, title and interest in and to all of the trademarks, trade names, business names, service marks, logos and business styles together with the goodwill associated with and symbolized by them, that are owned by the Assignor and used in the Business, including, without limitation, those trademarks, service marks, and trade names listed in Schedule A hereto (all such trademarks, service marks, and trade names referred to collectively as the "*Assigned Trademarks*").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor and the Assignee each hereby agree as follows:

1. Assignment. Assignor hereby sells, assigns, transfers, conveys and delivers to the Assignee and its successors and assigns, and the Assignee hereby purchases and accepts from the Assignor, all of Assignor's right, title and interest in, to and under the Assigned Trademarks, including, without limitation, all common law trademarks for which no applications or registrations exist, all applications to register any of the Assigned Trademarks, and all registrations that have been or may be granted for any of the Assigned Trademarks, together with all common law rights associated with the applications and registrations, and all goodwill associated with the Assigned Trademarks and symbolized thereby, together with the right to sue and recover damages for future, present and past infringements of the Assigned Trademarks and to fully and entirely stand in the place of the Assignor in all matters related to the Assigned Trademarks.

2. Miscellaneous. Assignor represents that Assignor has the rights, titles, and interests to convey the Assigned Trademarks as set forth herein, and covenants with Assignee that the Assignor has made or will make hereafter no assignment, grant, mortgage, license, or other agreement affecting the rights, titles, and interests herein conveyed.

3. Fax, PDF and Counterparts. This Assignment may be executed and delivered in original form, by facsimile or electronically by portable document format (PDF), and if so executed and delivered in any such form, such Assignment shall be deemed to be an original, and if executed in one or more counterparts, each counterpart shall be deemed to be an original copy of this Assignment and all of which, when taken together, shall be deemed to constitute one and the same instrument.


