TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("this Agreement") is entered into by and between Assignor, Moskowitz, Inc., a Pennsylvania corporation ("Assignor") and Assignee, PolicyPak Software Inc., a Pennsylvania corporation ("Assignee"), and is made with respect to the following recitals and is made effective Dec 2, 2013.

WHEREAS, Assignee has become the successor of the ongoing and existing business or portion thereof of Assignor related to the Assignor Trademark.

In consideration of the premises, mutual covenants and agreements contained in this Agreement, the parties agree as follows:

Terms and Conditions

1. Assignor hereby sells, assigns and transfers to Assignee all of Assignor's right, title and interest in and to the Assignor Trademark in any typeface, stylization, colors, and/or capitalization, and any U.S. state, federal or foreign applications and registrations of the foregoing, including the Assignor Applications, including the goodwill associated therewith (altogether, "the Assignor Trademark Rights"). Assignor will execute any documents reasonably necessary to effect the transfer of the Assignor Trademark Rights to Assignee.
2. Assignor acknowledges receipt of adequate consideration.
3. The parties hereto are separate and independent legal entities. Nothing herein contained will be construed or deemed hereby to create a principal/agent relationship between the parties nor any form of partnership or joint venture.


