
IP SUPPLEMENT NO. 5

This IP SUPPLEMENT NO. 5, dated as of November 30, 2013, is delivered pursuant to and supplements (i) the Patent Security Agreement, dated as of September 30, 2011 (said Patent Security Agreement, as it may hereafter be amended, supplemented, restated or otherwise modified from time to time, being the "Patent Security Agreement"), by and between Levi Strauss & Co. and JPMorgan Chase Bank, N.A., as Administrative Agent; and (ii) the Trademark Security Agreement, dated as of September 30, 2011 (said Trademark Security Agreement, as it may hereafter be amended, supplemented, restated or otherwise modified from time to time, being the "Trademark Security Agreement"); by and between Levi Strauss & Co. and JPMorgan Chase Bank, N.A., as Administrative Agent, the terms defined therein, executed by Pledgor.

Pledgor grants to the Administrative Agent a security interest in all of Pledgor's right, title and interest in and to the patent collateral and the trademark collateral as set forth on Schedules A and B hereto. All such collateral shall be deemed to be part of the Collateral and shall be hereafter subject to each of the terms and conditions of the Patent Security Agreement and the Trademark Security Agreement.
