## NUNC PRO TUNC TRADEMARK ASSIGNMENT

WHEREAS, **Tyco International Holding S.à r.l.** (R.C.S. NOW, therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor has and does hereby confirm the sale, assignment, transfer and set over unto the Assignee, *nunc pro tunc*, as a present acknowledgement of what has previously transpired, of the entire right, title and interest in and to the Mark, together with all goodwill and reputation attached or related to that portion of the business which is ongoing and existing to which the Mark pertains, and any cause of action related to the Mark, effective as of 26 September, 2012.
