## TRADEMARK ASSIGNMENT

TRADEMARK ASSIGNMENT, effective as of December 4, 2013 (the "Effective Date"), from GRIDSENSE, INC., a Colorado corporation (the "Assignor"), to WEIDMANN DIAGNOSTIC SOLUTIONS INC., a Delaware corporation ("Assignee").

Pursuant to that certain Asset Purchase Agreement dated as of December 4, 2013, between Assignor and Assignee, Assignor has agreed to assign to Assignee its entire right, title and interest in and to the trademarks and trademark registrations set forth on Schedule A attached hereto (collectively, the "Marks"), and the goodwill associated with the Marks.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign, sell and transfer to Assignee all of Assignor's right, title and interest in and to the Marks, together with the goodwill symbolized thereby, the United States trademark registrations listed on said Schedule A, and all rights to sue and collect damages for any past infringement of said Marks, misappropriation, unfair competition, dilution or other violation of the foregoing, and all rights to recover damages or lost profits in connection therewith, and all rights corresponding thereto.

Assignor authorizes and requests the Commissioner of the United States Patent and Trademark Office to record this Trademark Assignment.

Assignor hereby covenants and agrees that it shall cease and refrain from all use of the Marks in all countries of the World as of the Effective Date.
