RELEASE OF SECURITY INTEREST IN TRADEMARKS

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates and releases all of its security interests in and liens on all of the trademarks and trademark applications, including the Listed Trademarks and the associated business goodwill therein, granted in the Security Agreement, and the undersigned hereby acknowledges and agrees that it has no further interests in such trademark collateral and that such Security Agreement is terminated and of no further force and effect.

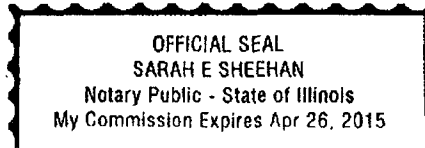
