**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of December 19, 2013, is made by The Bank of Nova Scotia (“Bank of Nova Scotia”), in favor of Sands Expo & Convention Center, Inc. (f/k/a Interface Group Nevada, Inc.) (“SECC”) as follows:

**W I T N E S S E T H**

WHEREAS, pursuant to the Trademark Security Agreement, dated May 23, 2007 (“Security Agreement”), and recorded with The United States Patent and Trademark Office on June 1, 2007 at Reel/Frame No. 3552/0953, SECC granted Bank of Nova Scotia a security interest in and to all of its right, title and interest in its trademarks and all applications and registrations therefor, including goodwill (the “Trademark Collateral”);

Bank of Nova Scotia agrees to provide SECC with any information and additional authorization necessary to effect the release of Bank of Nova Scotia’s security interest in the released Trademark Collateral.
