Section 1.01 Article I of the Articles of Incorporation of R. J. Ahmann Co. is hereby amended in its entirety to read as follows:

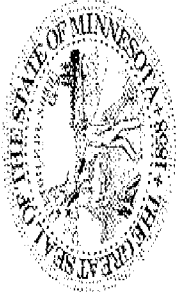
1.01 Name. The name of this corporation is **Ahmann & Martin Co.**
