SECURITY AGREEMENT


For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, **BRIAN HOROWITZ, CREATIVE OUTDOORS DISTRIBUTOR USA, INC., BAM BROKERAGE, INC. AND BRITT AND BROOKE INTERNATIONAL LIMITED** (collectively, "Debtors"), hereby grant to **H&H WHOLESALE SERVICES, INC.** ("Secured Party"), a continuing security interest in the Collateral as hereinafter defined to secure the payment and performance of Debtors' obligations arising under (a) a Promissory Note dated December 31, 2013 in the principal amount of \$36,000; (b) a Promissory Note dated December 31, 2013 in the principal amount of \$8,500; (c) a Promissory Note dated December 27, 2013 in the principal amount of \$24,080; and (d) any and all other present and future liabilities and obligations of Debtors to Secured Party of whatsoever nature. For the purposes hereof, the term "Collateral" shall mean any and all of the tangible and intangible property of Debtors, including all accounts receivable, goods, bank accounts, inventory, equipment, fixtures and general intangibles, as those terms are defined in the applicable Uniform Commercial Code, and any and all patents, trademarks and copyrights, including, but not limited to those attached hereto as Exhibit A. Debtors hereby irrevocably authorizes Secured Party to file any and all documents, including, but not limited to, financing statements, amendments to financing statements and continuations of any financing statements necessary to perfect the continuing security interest granted hereby.

Secured Party shall have all of the rights and remedies of a secured party under the Uniform Commercial Code for the State of Michigan.




