**MEMORANDUM AND NOTICE OF SECURITY INTEREST

SOLIGENT DISTRIBUTION LLC, a Delaware limited liability company (the “Debtor”) hereby acknowledges that it has granted to **WELLS FARGO BANK, NATIONAL ASSOCIATION** (“Lender”), 2450 Colorado Avenue, Suite 3000W, MAC E2040-030, Santa Monica, CA 90404 (the “Secured Party”), a security interest in and to all of such Debtor’s right, title and interest in and to: (a) the trademarks and trademark registrations and applications therefor which are identified on Exhibit A attached hereto and herein incorporated by this reference owned by such Debtor (the “Trademarks”), together with the goodwill and assets of the business; (b) the patents and patent applications which are identified on Exhibit B attached hereto and herein incorporated by this reference owned by Debtor (the “Patents”), and (c) the copyright registrations which are identified on Exhibit C attached hereto and herein incorporated by this reference owned by Debtor (the “Copyrights”), and all actions for infringement concerning each of the foregoing.

The terms and conditions of the aforementioned security interest are contained in that certain Security Agreement dated as of January 7, 2014 (the “Security Agreement”), among the Debtor, **SOLIGENT LEASING, LLC**, a Delaware limited liability company, **NSC ENERGY LLC**, a Delaware limited liability company, **STELLAR ENERGY GP, INC.**, a Delaware corporation, **SOLIGENT HOLDINGS INC.**, a Delaware corporation and Secured Party as security for the Obligations under and as defined in the Security Agreement and other agreements referred to therein. Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Secured Party may have in any other collateral described in the Agreement or otherwise.


