
WHEREAS, ASSIGNOR has agreed to assign the Trademark to the ASSIGNEE, and the ASSIGNEE hereby accepts said assignment.

ASSIGNOR hereby fully extinguishes its rights in the Trademark and retains no ownership rights or interest therein. ASSIGNOR agrees not to challenge the validity of ASSIGNEE'S rights in the Trademark, nor any use and/or rights in the Trademark by ASSIGNEE'S licensees or assignees. ASSIGNOR agrees it shall not use nor seek to register the Trademark or any mark confusingly similar with the Trademark.
