RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Release") is given as of January 17, 2014, by JPMorgan Chase Bank, N.A., a national banking association, located at 270 Park Avenue, New York, New York 10017 (the "Agent") for the benefit of AOL Inc., a Delaware corporation, located at 770 Broadway, 4th Floor, New York, New York 10003 (the "Debtor");

WHEREAS, Debtor has entered into a Contribution Agreement, dated as of January 15, 2014, by and between Debtor and Nullsoft Inc., a wholly-owned subsidiary of Debtor ("Nullsoft") pursuant to which certain trademarks and trademark applications set forth on Schedule A hereto (the "Trademarks") will be contributed to Nullsoft (the "Disposition");

WHEREAS, Debtor and Agent have entered into a Credit Agreement, dated as of July 1, 2013, together with certain other lenders, agents and bookrunners, and in connection therewith, Debtor has granted a security interest in the Trademarks pursuant to a Security Agreement, dated as of July 1, 2013, by and among Debtor, certain other subsidiaries of Debtor and Agent;


WHEREAS, in connection with the Disposition, Debtor has requested that the Agent release in accordance with Section 10.14 of the Credit Agreement, its security interest, and any other right, title and interest it may have in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Agent does hereby terminate and release any and all security interests and all other right, title or interest that it may have in, to or under, the Trademarks and thereby discharges the recordation of the Security Agreement against the Trademarks.
2. Agent agrees to take such further action as may be reasonably requested by Debtor, from time to time, at Debtor's expense, to effectuate and carry out the provision and intent of this Release.
3. Agent represents and warrants to Debtor that it has not conveyed, transferred, granted a security interest in, hypothecated or otherwise pledged or disposed of any of the rights, title or interest granted to the Trademarks under the Security Agreement to any party other than Debtor.
4. Agent hereby authorizes Debtor (or any other person authorized by or appointed by Debtor) to file this Release with the United States Patent and Trademark Office.
