CONFIRMATORY QUITCLAIM ASSIGNMENT

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby confirms that effective December 31, 2008, she sold, assigned, transferred and conveyed unto Assignee, its successors, assigns and legal representatives the entire right, title and interest in and to the Trademarks and Trademark Applications, together with all goodwill symbolized thereby as successor to the ongoing and existing business, or portion thereof, to which the mark pertains, together with all claims for damages by reason of past infringement thereof or act of unfair competition relating thereto, with


the right to sue for past and future damages, and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns, and legal representatives, with the same to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives.


