THE REPUBLIC OF ITALY

On the twenty-first day of December two thousand and eleven
(21 December 2011)

At Via Emilia 428-442, Ozzano dell'Emilia in the province of Bologna,
Before me, STEFANO FERRETTI, Notary Public in Bologna, registered with the
District of Notaries Public of Bologna, the following persons are present:

- MR. ALBERTO VACCHI born in Bologna on 17 February 1964 and domiciled for
the purpose at the address specified below, who is a party to this deed in his
capacity as Chairman of the Board of Directors and Legal Representative of the
company

"I.M.A. INDUSTRIA MACCHINE AUTOMATICHE S.p.A."

(hereinafter "IMA" or the "Company"), with offices at Via Emilia 428-442, Ozzano
dell'Emilia in the province of Bologna, share capital Euro 19,150,560 (nineteen
million one hundred and fifty thousand five hundred and sixty Euros) fully paid up,
registration number on the Companies Register of Bologna and tax code
00307140376, Business & Company Directory number BO-149288, in order to
execute the Board of Directors' resolution dated 20 October 2011 recorded in a
deed executed by me and numbered 18.467/4.951, registered at the Revenue
Office Bologna II on 20 October 2011 at number 12844, series 1T, filed on the
records of the Bologna Companies Register on 21 October 2011 (following the
filing of protocol number 869443/2011 dated 20 October 2011); authorised by
virtue of the Company's Articles of Association;

- SERGIO MARZO born in Turin on 16 March 1966, domiciled for the purpose at
the address specified below, who is a party to this deed in his capacity as
Managing Director and legal representative of

to execute the shareholders' resolution dated 20 October 2011 recorded in a deed
executed by me and numbered 18.463/4.948, registered with the Bologna II
Revenue Office on 20 October 2011 at number 12843, series 1T, filed on the
records of the Bologna Companies Register on 21 October 2010 (following the
filing of protocol number 69441/2011 dated 20 October 2011); authorised by virtue
of the Company's Articles Of Association;

Whereas

- the aforementioned resolutions issued by the respective executive bodies and
kept on the records of the respective Companies Registers on the dates and with
the protocol numbers indicated above, approved the merger by incorporation of
"IMA LIFE S.R.L." (the incorporated or newly-acquired company) into "I.M.A:
INDUSTRIA MACCHINE AUTOMATICHE S.p.A." (the incorporating company);
- as expressly stated on the plan of merger and in the above-mentioned
resolutions of approval, the entire share capital of the newly-acquired company
"IMA LIFE S.R.L." is owned by "I.M.A. INDUSTRIA MACCHINE AUTOMATICHE
S.p.A.";
- therefore, no resolution was passed to increase the share capital of the
incorporating company nor were any shares in that company allocated to a third

party; therefore, the sole consequence of the merger was the cancellation of all the share interests of IMA LIFE S.R.L. and the acquisition of all the assets of the newly-acquired company into those of the incorporating company;

- no amendments were authorised to the articles of association of the incorporating company;

- as the authorising company is listed on the STAR segment of the Milan Stock Exchange:

(i) the merger plan, reference balance sheets and resolution approving the merger were sent via the network information system (NIS) to CONSOB and Borsa Italiana S.p.A.;

(ii) the merger plan, reference balance sheets and resolution approving the merger were also published on the Company's website and deposited at its head office;

- the trade union representatives have been notified of the merger transaction in accordance with the terms stipulated in article 47(1) of law 428/90;

- the effect of the merger, as provided for in the resolutions approved as mentioned above, is governed as follows:

(i) under article 2504-*bis* of the Civil Code, the merger shall take effect after the last of the registrations of the deed of merger as required under article 2504 of the Civil Code, or, if the last registration was made prior to 31 December 2011, with effect from 1 January 2012;

(ii) under article 2501-*ter*, subparagraph six of the Civil Code and for tax purposes, the operations of the newly-acquired company will be allocated to the balance sheet of the incorporating company with effect from the first day of the financial year in which the merger took legal effect in accordance with the foregoing subparagraph;

- in the resolutions mentioned above, the executive bodies of the parties to the merger transaction authorised the Boards Of Directors pro tempore, having established the legal conditions for execution of the deed of merger, to formalise the deed of merger and act as signatories to the notarial deed with all the necessary powers, and to carry out all the related formalities;

- as expressly declared to me by the appearing parties who have been informed by myself, Notary Public, of the civil and criminal liabilities arising from false declarations pursuant to the provisions of Presidential Decree 445 of 28 December 2000, and article 76 of the same decree, no objections were lodged at the Court of Bologna (with regard to I.M.A. INDUSTRIA MACCHINE AUTOMATICHE S.p.A. or IMA LIFE S.R.L.) in relation to the authorised merger, within the legal period of 60 days (article 2503 of the Civil Code) from the date on which the above-mentioned approvals were entered in the respective Companies Registers, which as mentioned were made on 21 October 2011 for both parties to the merger;

- the balance sheets of the parties to the merger have not undergone any material changes in the meantime which could undermine or alter the financial and legal foundations underlying this merger transaction;

- therefore, as the legal conditions exist, the appearing parties in their capacities as mentioned above, now intend to formalise the merger;

In consideration of the foregoing, which forms an integral and substantial part of this deed

It is now agreed and stipulated as follows:

Article 1) IMA LIFE S.R.L. is hereby merged by incorporation into the incorporating company I.M.A. INDUSTRIA MACCHINE AUTOMATICHE S.p.A., in execution of the resolution approving the related merger plan passed by the parties to the merger on 20 October 2011, as described above.

Article 2) It is hereby agreed that the effect of the merger, as provided for in the above-mentioned resolutions of approval, shall be governed as follows:

- pursuant to article 2504-*bis* of the Civil Code, the merger shall take effect from the date of the last registration to the deeds of merger required under article 2504 of the Civil Code, or, if said last registration was made prior to 31 December 2011, on the first day of January 2012 (two thousand and twelve);
- pursuant to article 2501-*ter*, subparagraph six of the Civil Code and for tax purposes, the operations of the newly-acquired company shall be allocated to the balance sheet of the incorporating company with effect from the first day of the financial year in which the merger takes effect in accordance with the foregoing subparagraph.

Article 3) The appearing parties hereby acknowledge:

(i) that the merger shall not result in any increase to the share capital of the incorporating company nor any allocation of shares in that company to a third party; the sole consequence of the merger shall be the cancellation of the entire share interest of IMA LIFE S.R.L. and the acquisition by the incorporating company of all the assets of the incorporated company;

(ii) likewise, no amendments to the articles of association of the incorporating company have been authorised.

Article 4) Considering that the incorporated company shall cease to exist as a result of this merger transaction, I.M.A. INDUSTRIA MACCHINE AUTOMATICHE S.p.A. shall by law acquire all the assets and liabilities of the newly acquired company IMA LIFE S.R.L. and all the claims, actions, rights, patents, trademarks, copyrights, obligations, commitments and liabilities of any type and nature with no exceptions or exclusions whatsoever; including the possibility of utilising the VAT threshold referred to in article 8(2) of Presidential Decree 633/1972.

Article 5) Any person, body or private or public office shall therefore be authorised, with no requirement for any further formality and with an exemption from liability - taking into account the effective date of the merger as expressly governed in article 2 above - to transfer and place in the name of the incorporating company I.M.A. INDUSTRIA MACCHINE AUTOMATICHE S.p.A. all the deeds, documents, guarantee deposits and other securities, policies, patents, trademarks, debit and credit accounts currently held in the name of the incorporated company IMA LIFE S.R.L. and to consider I.M.A. INDUSTRIA MACCHINE AUTOMATICHE S.p.A. the sole owner of all the assets, liabilities, rights, credits, debts, exposures, contractual positions, situations and any other relationship with legal significance relating to the incorporated company.

For the purposes of the above transfer and deposit at the competent offices, the appearing parties, in their capacities as mentioned above, hereby confirm that IMA LIFE S.R.L. owns the following:

- (i) the rights deriving from the patents and trademarks further described in the schedule annexed hereto at Appendix A, which has not been read out to the parties who have given their express waiver in this regard;
- (ii) the NISSAN truck with registration number BH693GC;
- (iii) the equity investments in the list annexed hereto at Appendix B, which has not been read out to the parties who have given our express waiver in this regard.

Without prejudice to the foregoing, the executive body of the incorporating company I.M.A. INDUSTRIA MACCHINE AUTOMATICHE S.p.A., through the Chairman of The Board Of Directors:

(i) is expressly authorised to carry out all the formalities which may be necessary or even merely appropriate, resulting from the merger hereby formalised, with no exclusions or exceptions whatsoever and excluding the possibility of any objections being raised in relation to a lack of powers in this regard, and in particular, to cancel the shares constituting the share capital of IMA LIFE S.R.L. and to transfer all the assets and liabilities to the incorporating company, to make the communications required by law, to formalise all the deeds, supplementary deeds and documents which are necessary or even merely appropriate to secure the formal acquisition by the incorporating company of the assets and liabilities of the incorporated company;

(ii) is expressly authorised to execute any supplementary documents with the aim of providing a more specific description and definition of:

- the rights, trademarks, patents, registered movable assets and any other right or tangible or intangible assets which may require registration or notification of the completed merger and resulting transfer to the incorporating company with public offices or registers or any other public or private entity;

- more in general, any other movable or immovable assets, tangible or intangible assets or rights transferred, in respect of which a more accurate or precise description or definition is necessary or even merely appropriate; consequently, the rectification of any inaccurate or incomplete data, with all the necessary powers; acting in the name and on behalf of all the companies party to this merger transaction without the possibility that any objection to any lack of powers can ever be raised in this regard.

Article 6) From the effective date of this merger, all the executive bodies of the incorporated company IMA LIFE S.R.L. shall cease from office, and in particular the Board of Directors, the Board of Auditors and the Supervisory Committee appointed pursuant to article 6 of legislative decree 231 of 8 June 2001.

Article 7) Likewise, any and all special or general powers of attorney conferred by the incorporated company IMA LIFE S.R.L. upon any individual or corporation in whichever form or legal configuration - except for the powers indicated in article 8 below - shall be considered to have terminated and shall be without effect from the effective date of the merger as stipulated above.

For ease of reference only, the following paragraphs contain a non-exhaustive list of powers of attorney granted in the name of the incorporated company which shall be deemed to have terminated by law and shall be without effect and are hereby revoked for all legal purposes:

c) power of attorney to VITTORIA FRASSINETI born in Faenza in the province of Ravenna on 15 April 1966, domiciled at via J. F. Kennedy 3, Castel San Pietro Terme in the province of Bologna, tax code FRS VTR 66D55 D458U, appointed by a deed executed by me on 1 June 2010, index number 17097/4133, registered at Revenue Office Bologna II on 8 June 2010 under number 7536.

The company I.M.A. INDUSTRIA MACCHINE AUTOMATICHE S.p.A. hereby accepts the obligation to notify the above revocations to the proxies concerned, and to this end hereby confirms that the revocations shall not be effective until made known to the proxies, also pursuant to article 1729 of the Civil Code, and that the same revocations shall not be opposable to third parties pursuant to article 1396 of the Civil Code unless the same have been informed by appropriate means. For this purpose, this deed will be deposited with the competent Companies Register.

Article 8) Vice-versa, the powers of attorney listed below are hereby confirmed in full and shall therefore be fully effective and binding upon the incorporating company as if they had been issued by the incorporating company itself I.M.A. INDUSTRIA MACCHINE AUTOMATICHE S.p.A., which must therefore arrange for the filing of this deed with the Companies Register, also for said purpose, subject to any subsequent revocations to be executed in accordance with the appropriate procedure:

a) power of attorney to GIANNI BALBONI born in Argenta in the province of Ferrara on 8 November 1960, resident at Via Pasubio 9 Molinella in the province of Bologna, tax code BLB GNN 60S08 A393P, appointed by a deed executed by me on 21 February 2007 with index number 14358/2470, registered at Revenue Office Bologna II on 6 March 2007 under number 720;

b) power of attorney to FABRIZIO COLLA born in San Secondo Parmense in the province of Parma on 18 March 1971, resident at Via Stradello Chiesa Eja 8, Parma, tax code CLL FRZ 71C18 I153R, appointed by a deed executed by me on 25 September 2008, index number 15658/3293 registered at Revenue Office Bologna II on 29 September 2008 under number 11902.

Article 9) It is hereby acknowledged that in relation to the lease agreements currently in existence, the incorporated company IMA LIFE S.R.L. is named as the tenant in the following agreements:

I) Marinelli/IMA LIFE S.R.L. executed on 2 January 2007 and registered at the Revenue Office Bologna IV on 30 January 2007, under number 847;

II) Luciano Fumanti/IMA LIFE S.R.L. executed on 10 October 2003 and registered with the Revenue Office of Prato II on 6 November 2003 under number 3948;


III) Farne-Gambetti/IMA LIFE S.R.L. executed on 3 September 2010 and registered with the Revenue Office of Imola on 3 September 2010 under number 13.624;

IV) Annoni/IMA LIFE S.R.L. executed on 1 June 1999 and registered at the Bologna III Revenue Office on 17 June 1999, under number 4178.

Article 10) This deed of merger, pursuant to article 4(b) of the First Section of the Tariff annexed to Presidential Decree number 131 of 26 April 1986, is subject to registration tax at the standard rate.
