RELEASE OF LIENS ON INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST is given as of January 30, 2014, by Ampersand 2001 Limited Partnership Fund and Ampersand 2001 Companion Fund Limited (“Lenders”), in favor of Kortec, Inc. WHEREAS, pursuant to that certain Patents and Trademarks Security Agreement, dated as of September 16, 2005, by and between Lenders and Grantor (the “Assignment”), and certain other collateral documents, Grantor granted to the Lenders a continuing security interest in certain personal property of Grantor, including all right, title and interest of Grantor in, to and under all patents and patent applications of the Grantor and trademarks and trademark applications of the Grantor (the “Collateral”), to secure the Grantor’s secured obligations to Lenders pursuant to the terms of the Assignment.

WHEREAS, the Assignment was recorded on September 23, 2005 in the United States Patent and Trademark Office under Reel 3164, Frame 0488.


WHEREAS, Lenders have agreed to release its security interest in the Collateral covered by the Assignment.


