RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST ("Release") is made this 13th day of ~~February~~, 2014 (the "Effective Date"), by and between Intelli-Check, Inc., with an address at 775 Park Avenue, Suite 340 Huntington, New York 11743 ("Intelli-Check"), and Soneet R. Kapila, as Liquidating Agent for GunnAllen Financial, Inc., with an address of 1000 South Federal Highway, Fort Lauderdale, Florida 33316 ("GunnAllen"), in its bankruptcy case no. 8:10-bk-9635-MGW in the United States Bankruptcy Court for the Middle District of Florida.

WHEREAS, Intelli-Check and GunnAllen Financial, Inc. are parties to a "Security Agreement" dated September 21, 1999 (the "Security Agreement");

WHEREAS, GunnAllen Financial, Inc. was also designated and appointed as the agent ("Agent") under the Security Agreement on behalf of the Note Holders as defined in the Security Agreement;

WHEREAS, the Security Agreement granted to the Note Holders a first priority continuing interest in all of the assets of Intelli-Check, which assets included, but were not limited to, certain Trademarks and Patents, including the Trademarks and Patents listed in Schedule A and Schedule B respectively, attached hereto, (collectively, the "Collateral"), as security for certain obligations of Intelli-Check to GunnAllen Financial, Inc.;

WHEREAS, pursuant to the Security Agreement, GunnAllen Financial, Inc., as Agent, filed the Security Agreement with the United States Patent and Trademark Office to perfect the Note Holders' interest in the Collateral;

WHEREAS, the Security Agreement with respect to Trademarks is recorded in the United States Patent and Trademark Office on November 12, 1999 at microfilm reel #1988, frame #0738;


WHEREAS, the Security Agreement with respect to Patents was recorded in the United States Patent and Trademark Office on November 12, 1999, at microfilm reel #010371, frame #0861;

WHEREAS, Intelli-Check repaid the Note Holders pursuant to the November 24, 1999 letter of instructions from GunnAllen Financial, Inc., captioned "Re: Intelli-Check, Inc. Repayment of Promissory Notes," which provided for the repayment of \$1,221,666.47 representing the aggregate amount of principal and interest then due and payable to the Note Holders under the Security Agreement.

Kapila, as Liquidating Agent for GunnAllen Financial, Inc., as Agent for the Note Holders, hereby relinquishes his interest unto Intelli-Check, to the extent any may exist, the continuing security interest in the Trademarks listed in Schedule A, the Patents listed in Schedule B, and any US or foreign jurisdiction, Patents or Patent Applications claiming priority to the listed Patents under United States law or international convention, including but not limited to continuations, divisionals, reissues, reexaminations, extensions, and substitutions of such Patents. No representations or warranties are made by GunnAllen as to the present existence or perfection of said trademarks or patents.
