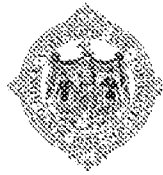

Pursuant to Section 2-607 of the Maryland General Corporation Law, TSS SOFTWARE CORPORATION (the "Corporation"), a Maryland corporation, having its principal office in Annapolis, Maryland, hereby certifies that:

(a) The Articles of Incorporation of the Corporation are hereby amended by deleting therefrom ARTICLE FIRST in its entirety and substituting in lieu thereof the following new ARTICLE FIRST:

FIRST: The name of the corporation (hereinafter, "Corporation") is MILLER TRANSITION SERVICES, INC.

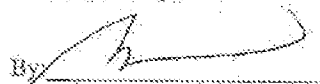
