3. **NO CHALLENGE.** Assignors agree not to challenge or assist or cooperate with any third party in challenging or in taking any position contrary to or inconsistent with Assignee's sole and exclusive rights in and to all Trademarks or the validity of Assignee's ownership thereof.
4. **COUNTERPARTS.** This Agreement may be executed in two or more counterparts, each of which as so executed shall be deemed to be an original and such counterparts together shall constitute one and the same instrument.

IN WITNESS WHEREOF, Assignors have executed this agreement by its duly authorized representative on the Effective Date.

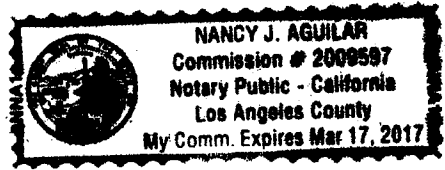
