RECITALS

WHEREAS, Assignor filed an intent-to-use application for the trademark (the "Mark"), identified as follows:

WHEREAS, Assignor has a bona fide intention to use the Mark in the regular course of its ongoing and existing business by developing the goods to which the Mark pertains.

NOW, THEREFORE, in consideration of the payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign and transfer to its successor Assignee its entire right, title and interest in and to the Mark, together with only that portion of the ongoing and existing business to which the Mark pertains, development and marketing to which the Mark pertains, and any and all rights of recovery based on past infringement of said Mark, the same to be held and enjoyed by Assignee, its successors and assigns.
