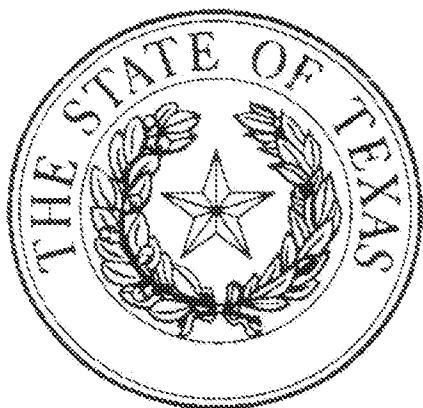

Article 5 - Series
