## Trademark Assignment

This Trademark Assignment ("Assignment") is made and entered into effective as of March 24, 2014 (the "Effective Date") by and between Zhishin Capital, LLC, a limited liability company existing under the laws of the State of Delaware ("Assignor"), and Advantra Z, Inc., a corporation existing under the laws of the State of New Jersey ("Assignee").

- A. Assignor is the owner of the registered trademarks and pending applications for trademarks (collectively, the "Trademarks") listed in Exhibit A attached hereto; and
- B. Assignee wishes to acquire, and Assignor is willing to sell, assign, convey, and transfer to Assignee, all right, title and interest in and to each of the Trademarks listed in Exhibit A, together with the goodwill of the business symbolized by the Trademarks on the following terms and conditions.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Assignor and Assignee, the parties agree as follows:

1. Assignment. Assignor hereby irrevocably grants, assigns, conveys, transfers and sets over to Assignee, its successors and assigns, all of its right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks, and all claims, demands, income, damages, royalties, payments, accounts and accounts receivable now or hereafter due and/or payable, and rights of action, both statutory and based upon common law, that Assignor has or might have by reason of any past, present or future infringement or other violation of any of the Trademarks prior to, on, or after the date of this Assignment, together with the right to prosecute such claims, demands, and rights of action in Assignee's own name, all of said rights to be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.
2. Authorization. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and the corresponding entities or agencies in any applicable foreign countries, to issue the same to Assignee in accordance with the terms of this Assignment and to record Assignee as owner of the Trademarks, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.
3. Cooperation. Assignor agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by Assignee to effectuate more fully the transactions contemplated by this

Assignment. The cost of recording and registering ownership rights in the Trademarks shall be borne solely by Assignee, its successors and assigns.

4. Miscellaneous. This Assignment and the exhibits hereto constitute the entire understanding and agreement of the parties with respect to the subject matter hereof and supersede any and all written or oral, prior or contemporaneous understandings and agreements. This Assignment may only be amended by written agreement of the parties. This Assignment may be executed and delivered by facsimile or portable document format in two or more counterparts, each of which shall be an original and all of which together shall constitute one and the same instrument. This Assignment shall be binding upon the parties, their heirs, successors and assigns, and all others acting by, through, with or under their direction, and all those in privity therewith. The governing law of this Assignment shall be that of the State of Delaware without regard to its conflicts of law principles.

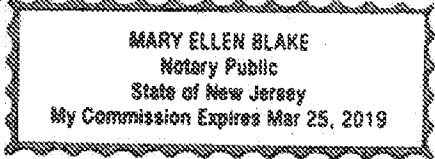
